II. WHEREAS the Government of Telangana has offered to extend the required infrastructure and other facilities, as also financial assistance, for setting up a world class international arbitration centre and mediation centre at Hyderabad, capital of Telangana.

III. WHEREAS the Author of the Trust has decided to declare a Public Charitable Trust to promote, establish and maintain such Arbitration Centre and Mediation Centre of international standards at Hyderabad for promoting alternate dispute resolution (“ADR”) processes in India.

IV. NOW THIS DEED OF DECLARATION OF TRUST WITNESSES AS FOLLOWS:

1. CREATION OF THE TRUST

The Author of the Trust hereby declares and establishes a Public Trust known as **“THE INTERNATIONAL ARBITRATION & MEDIATION CENTRE TRUST, HYDERABAD”** for the development of Alternative Dispute Resolution processes, in particular arbitration and mediation.

2. OFFICE OF THE TRUST

The Registered Office of the Trust shall be situated at Ashok Vihar, Road No 7, Banjara Hills, Hyderabad. The Trustees may establish branches of the Trust at such other place or places as they may decide upon from time to time.

3. OBJECTS OF THE TRUST

The Objects of the Trust are -

- (i) to promote and develop arbitration, mediation and other alternative dispute resolution processes, with the object of providing effective and expeditious justice;
- (ii) to establish, maintain and operate an arbitration and mediation centre for international and domestic arbitrations and mediation under the name and style of **“International Arbitration & Mediation Centre, Hyderabad”** at Hyderabad;
- (iii) to establish, maintain and operate arbitration centres and mediation centres at other places in India;

- (iv) to coordinate and collaborate with other domestic and international institutions involved in the creation, development and conduct of alternative dispute resolution processes including arbitration and mediation, to achieve and fulfil the objects of the Trust; and
- (v) to conduct training courses, awareness programmes, workshops, conferences, lectures and encourage research to build and promote Alternative Dispute Resolution processes, in particular, arbitration and mediation for settlement of commercial disputes.

4. BOARD OF TRUSTEES

4.1 The Board of Trustees shall consist of (i) two 'Life Trustees'; (ii) two 'Ex-officio Trustees'; and (iii) three 'Term Trustees'.

4.2 The Author of the Trust appoints the following two Life Trustees to hold office for life:

(a) Hon'ble Mr. Justice L. Nageswara Rao, Judge, Supreme Court of India

(b) Justice (Retd.) R.V. Raveendran, former Judge, Supreme Court of India

4.3 The Author of the Trust appoints the following two *Ex-Officio* Trustees (to hold office during their respective official tenures):

(a) Hon'ble Justice Hima Kohli Chief Justice of Telangana

(b) Shri A. Indrakaran Reddy Hon'ble Law Minister, Government of Telangana

4.4 The Author of the Trust hereby provides that there shall also be three Term Trustees who shall be nominated initially by the Life Trustees. The Term Trustees will hold office for a term of three years.

4.5 The term of office of Life Trustees shall be for their Life or until they voluntarily resign from office. They shall also cease to hold office, on being declared insolvent or found to be suffering from any medical incapacity which prevents them discharging their functions. Any vacancy in the office of Life Trustees shall be filled by the remaining members of the

Board of Trustees. The persons to be appointed as Life Trustees shall be either sitting or retired Judges of the Supreme Court or a Retired Chief Justice of any High Court.

4.6 The term of office of the *Ex-Officio* Trustees shall be co-terminus with the respective office held by them. The two *Ex-officio* Trustees shall be (a) The Chief Justice of Telangana High Court; and (b) The Minister of Law, Government of Telangana. When a vacancy arises in the office of any of the *Ex-officio* Trustees, his/her successor in that office will automatically become the *Ex-Officio* Trustee in his/her place.

4.7 The term of office of the Term Trustees shall be three (3) years. Any vacancy in the office of Term Trustees shall be filled by the Board of Trustees. The Term Trustees shall be nominated from among sitting and retired judges of the Supreme Court of India & the High Court of Telangana, members of the bar with expertise in the field of alternative dispute resolution processes, and elected representative(s) of reputed industry bodies. Term-Trustees shall be eligible for re-appointment for another term.

4.8 A Term Trustee shall cease to hold office by resignation. Any Term Trustee may be removed by three-fourth majority of the members of the Trust if (i) it is found that any act of such Trustee is detrimental to the objects and purpose of the Trust; (ii) the Trustee is declared as an insolvent; or sentenced for any offence; and (iii) the Trustee suffers from any incapacity preventing him/her from performing his / her functions.

5. INITIAL FUND, CORPUS, INCOME AND PROPERTIES OF THE TRUST

5.1 The Author of the Trust has contributed/settled a sum of Rs. 10,116 (Rupees Ten thousands One Hundred and Sixteen) which shall be the initial fund of the Trust.

5.2 The properties of the Trust shall be-

- (a) the initial fund contributed/settled by the Author of the Trust;
- (b) all properties - movable or immovable - acquired by the Trust either by purchase, gift or otherwise; and
- (c) all grants and contributions by the Government and other authorities; and all donations, gifts or grants by any well-wisher of the Trust and accepted by the Trust.

5.3 The funds and income of the Trust shall be utilised solely for the purpose of achieving the Objects of the Trust. No part of the funds, assets or property of the Trust shall be paid or distributed to or utilised by any Trustee by way of remuneration, profit, interest, dividend or otherwise.

5.4 All the assets of the Trust shall vest in the Trust and the Board of Trustees shall manage and administer the affairs of the Trust.

6. POWER OF THE TRUSTEES

The Board of Trustees shall have the control and management of the Trust and exercise the following powers:

- a) Establish, manage and run institutions for the development and operation of arbitration, mediation and other Alternative Dispute Resolution processes.
- b) Determine from time to time, the purposes for which the funds of the trust shall be allotted and used to achieve the objects of the Trust.
- c) Purchase/acquire any immovable or other properties/assets for the use of the Trust and its institutions or to provide sources of income for achieving the objects of the Trust.
- d) Sell, lease, mortgage or dispose of any property/asset – immovable or otherwise belonging to the Trust.
- e) Incur all expenditure necessary for carrying out the objects and administration of the Trust.
- f) Open and operate bank account/s of the Trust with any bank/s as the Trustees may deem fit. The Board of Trustees can authorise the CEO and any one of the Trustees to operate the account/s.
- g) Borrow for and on behalf of the Trust with or without security from banks, Governments, or any other government bodies.
- h) Incur such other items of expenditure as is necessary and incidental for carrying out the objects of the Trust.
- i) Institute/defend any suit or proceedings and in that behalf, compound, withdraw, compromise, adjust, refer to arbitration/mediation/conciliation or do such things as are incidental and necessary in regard to such litigation, concerning the affairs of the Trust and sign and verify vakalatnamas, pleadings, affidavits.
- j) Engage the services of architects/engineers/advocates for the purposes of the Trust.
- k) Frame rules, regulations, byelaws and other codes for the conduct of the affairs of the Trust, its Institutions and Committees.

- l) Accept contributions in cash or in kind either by way of addition to the trust funds generally or for any one or more of the specified objects of the Trust.
- m) Constitute/establish the Governing Council and other committees to fulfil/achieve the objects of the Trust and to delegate any of its functions to such Council or committee.
- n) Appoint a Chief Executive Officer (CEO) with suitable qualification to manage the activities of the Trust, its institution and to assist the Board of Trustees in carrying out the aforesaid activities.
- o) Employ the services of staff for carrying out the objects of the trust and terminate their services.
- p) To do all other acts, deeds and things necessary for proper management of its institutions and for fulfilling the objects of the Trust.

7. Appointment of Governing Council and Delegation of powers of Trustees

7.1 The Board of Trustees shall constitute a Governing Council consisting of maximum 15 members for managing and running the institutions established by the Trust. Life Trustees shall be Members of the Governing Council. The remaining Members of the Governing Council shall be appointed by the Board of Trustees from among internationally reputed arbitrators, mediators, ADR practitioners, retired Judges, and representatives of industry/business. The Term Trustees shall be eligible for appointment as members of Governing Council.

✓ 7.2 The CEO or in his absence the Registrar shall act as the Secretary of the Governing Council.

7.3 The term of the Governing Council shall be three years. Members of the Governing Council will be eligible for reappointment.

7.4 The duties, powers and functions of the Governing Council shall be as per the byelaws formulated by the Board of Trustees.

7.5 Unless the Board of Trustees unanimously resolve otherwise, the decision of the Governing Council shall be final in all matters pertaining to the institutions established by the Trust.

8. Meetings of the Trustees

8.1 Meetings of the Board of Trustees shall be presided by a Life Trustee. In the absence of the Life Trustees, any Trustee elected by the Trustees present may preside over the meeting of the Board of Trustees.

8.2 The Board of Trustees shall meet (physical or virtual) at least twice a year. In addition, the CEO shall convene the meeting of the Board of Trustees with a week's notice (through email), at the request of any Member of Board of Trustees. The Board of Trustees may also take decisions/pass resolutions by circulation.

8.3 The quorum for any meeting of the Board of Trustees shall be three. In the event of a tie in voting, the person presiding such meeting shall exercise casting (additional) vote.

9. ACCOUNTS AND AUDIT:

9.1 The Trustees shall maintain true and correct accounts of all Trust monies and of all the income and investments and all the outgoing expenses.

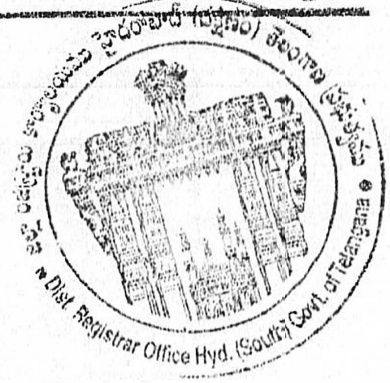
9.2 The year of account shall be the financial year commencing from 1st April and ending 31st March.

9.3 The Trustees shall each year issue a report setting out the accounts showing the income and expenditure of the Trust for the preceding year not later than six months from the end of the preceding year of accounts.

9.4 The accounts of the Trust shall be audited every year by a Chartered Accountant who may be appointed for the purpose by the Board of Trustees and the audited statement of accounts together with Auditors' report shall be laid before the Board of Trustees for approval.

10 POWER TO AMEND AND POWER TO MAKE/ALTER RULES, REGULATIONS AND BYELAWS

10.1 The Board of Trustees shall have full power and authority to make, alter and rescind rules, regulations and byelaws for the management and administration of the Trust and its institutions. Any amendments to the byelaws of the Governing Council of any institution of the Trust shall be made in consultation with the respective Governing Council.

10.2 Any amendment to the Trust Deed will be carried out only with the approval of three-fourths of the Members of the Board of Trustees and the Commissioner of Income Tax. Further, no amendment or alteration to the Trust Deed, Rules, Regulations and Byelaws shall be in violation of the provisions of Sections 2(15), 11, 12, 13 and 80G of the Income Tax Act, 1961.

11 APPLICATION OF INCOME AND TRUST FUND

The Board of Trustees shall be empowered to invest the funds of the Trust in movable or immovable properties, in such manner as they deem fit for the purpose of the objects of the trust provided that such investments shall be in accordance with the provision of Section [13(1)] read with Section [11(5)] of the Income Tax Act, 1961 and any other law for the time being in force as are applicable to charitable trusts.

12 BAR ON REMUNERTION TO THE TRUSTEES

The Trustees are not entitled for any remuneration. They shall however be entitled to receive out-of-pocket expenses incurred by them in the course of discharging the functions of the Trust.

13 INDEMNITY

Each Trustee shall be indemnified by the Trust in respect of all decisions taken in good faith, against all proceedings, suits, claims, costs, damages and expenses occasioned by any claim in connection with the matters or affairs relating to the Trust or in the exercise of powers or discretion vested in them under this Deed.

The Trust is irrevocable. In the event of dissolution, all assets of the Trust shall be transferred to an association of persons or trust or society having similar objects of this Trust.


