He is an L-4 Certified Mediator by the Singapore International Mediation Institute (the highest level from SIMI) and accredited by the Straus Institute for Dispute Resolution, Pepperdine University, USA. He is also an International Honorary Senior Fellow of the Straus Institute for Dispute Resolution, Pepperdine University, USA. Mr. Chandhiok is a member of the Russian Centre for Dispute Resolution of the BRICS Forum, the London Court of International Arbitration, the Singapore International Arbitration Centre (SIAC) and the Indian Council of Arbitration. He has a special interest in arbitration and mediation and has been a mediator, arbitrator and arbitration counsel in many international and domestic arbitrations. He is well-known in mediation ever since the mediation movement started in India. He is also a trainer in mediation. He is a well-recognised name and is a sought-after counsel in commercial, insolvency, and corporate law. Mr. Chandhiok is currently the President-Elect of The Bar Association of India and President of Maadhyam International Council for Conflict Resolution. He was also President of the Delhi High Court Bar Association six times. Many prestigious awards were conferred on him, and he holds two doctorates (honoris causa). Mr. Chandhiok graduated in law from Delhi University, securing the first position.
