Justice B. Sudershan Reddy

Justice B. Sudershan Reddy, former Supreme Court Judge and Goa's first Lokayukta, earned his law degree from Osmania University in 1971. He was appointed Government Pleader in 1988, served as Additional Standing Counsel, and became President of the Andhra Pradesh High Court Advocates Association in 1993. That same year, he was appointed High Court Judge, later served as Chief Justice of the Gauhati High Court in 2005, and was elevated to the Supreme Court in 2007, wherein he served till 2011.



Justice R.V. Raveendran

Justice R.V. Raveendran enrolled as an advocate in March 1968 and became a Permanent Judge of the Karnataka High Court in February 1993. He was appointed Chief Justice of the Madhya Pradesh High Court in July 2004 and elevated to the Supreme Court in September 2005, retiring in October 2011. Since then, he has served as an arbitrator in various domestic and international matters and has been appointed to several committees by the Supreme Court and the Government of India.

OBJECTIVES ENVISIONED

For Year 2025

IAMC has been concentrating its efforts in three key areas

- Encouraging the use of mediation and arbitration in both international and domestic civil/commercial matters by incorporating IAMC clauses into contracts;
- Promoting academic growth by training students in problem-solving and conflict resolution skills;
- Advancing community mediation initiatives to support grassroots-level dispute resolution for family, social, and community conflicts; and

As part of its capacity-building initiative, IAMC has been training and empanelling qualified mediators and arbitrators for civil/commercial as well as community mediation and arbitration.

Infrastructure & Ameneties

Ongoing improvements, under the guidance and supervision of Ms. Radha and Mr. Mahesh (Administrative Head and IT Head respectively), are being made to upgrade infrastructure and services. This includes the implementation of Aldriven case management systems, enhancements to existing facilities, provision of amenities such as coffee vending machine, infused water and refreshments, and the establishment of Annual Maintenance Contracts (AMCs) to ensure smooth operation of essential services like air conditioning, internet, and electrical systems. Feedback is being taken from visiting arbitrators and lawyers regarding the facilities in order to ensure user satisfaction.

Below is an overview of IAMC's activities, ongoing programs and planned activities from January 2025 to the present.

For Year 2025

I. The Arbitrator's Path: A Course for Women in Arbitration

IAMC Hyderabad organised specialised 40-hour intensive training programme designed to support and advance women in the field of arbitration. The program was Women's announced on Day and concluded with a two-day in-person practical workshop and assessment. The training saw resource persons from leading law firms having the professional experience and expertise in arbitration, offering their services pro bono.

This training programme, for a cohort of 30 participants, was organised at a nominal cost to promote gender diversity in arbitration appointments, and is being closely monitored by the Deputy Registrar, Ms. Nikshita Niranjan, and Associate Counsels Ms. Isha Janwa and Ms. Anandita Rajesh. Upon successful completion of the training and a rigorous assessment, who candidates qualify will empanelled with IAMC Hyderabad as arbitrators.

II. Certified Mediation Training Programme with Comprehensive Industry Focus

IAMC Hyderabad collaborated with the Insolvency Professional Agency of the Institute of Cost Accountants of India and Missing Bridge to organize a mediation training programme with a particular focus on IBC, Startup, and MSME disputes. The aim of this training was to create a qualified pool of mediators equipped with the skills to deal with IBC matters.

(Mediation Training Programme concluded on 19 April 2025)

III. Mediation Training Programme for Members of the Telangana High Court Advocates' Association (THCAA)

A cohort of 30 participants were provided a 5 day training at nominal costs. The training concluded on 26 January 2025 assessment concluded and on 26 February 2025. Mr. A.J. Jawad was also invited to address members of the THCAA regarding mediation and the services being offered by IAMC. Following the meeting, an expression of interest to undergo mediation training was received from more than 90 advocates. IAMC is planning to offer mediation training to the Telangana advocates at subsidised rates.

IV. Family Mediation Training Programme

IAMC Hyderabad conducted a seven-day intensive workshop on Family Mediation Skills in collaboration with Invisible Scars Foundation (ISF) and Centific, aimed at equipping social workers with tools to address domestic violence and genderbased conflict through mediation. The programme saw participation from organisations such as CFAR, Wishes Foundation, and Seva Bharathi. Sessions were led by Mr. K. S. Sarma, CEO, Life Skills (India) Training Pvt. Ltd.; Susheela Sarathi, Senior Advocate, High Court of Karnataka, Senior Mediator and Master Trainer at the Bangalore Mediation Centre and MCPC; Mr. Ranjeeth Thunga, Varudhini Perspective Mapper; Dr. Kankipati, Psychologist; and Tanu Ms. Legal Counsel, Mediator Mehta, and Arbitrator, Committee for Mediation and Conciliation. Bombay Chamber of Commerce.







The training was conducted with a strong focus on trauma-informed practices and practical mediation exercises. The training concluded with an assessment and valedictory ceremony, reaffirming IAMC's efforts to build capacity in community-based dispute resolution. The course curation and coordination was led by Ms. Isha Janwa, Associate Counsel, IAMC.

VI. Qualifying Assessment Programme (QAP)

IAMC Hyderabad conducted a three-day Qualifying Assessment Programme (QAP) for mediators. The programme featured a one-day masterclass led by Mr. A.J. Jawad, Registrar, IAMC Hyderabad and Senior Mediator Trainer, followed by structured mock roleplays and formal assessments. Participants who successfully complete the assessment process will be empanelled as mediators with IAMC Hyderabad, contributing to the Centre's growing panel of qualified professionals.

Tribunal Secretary Training

01

Tribunal Secretary Training is being offered to young lawyers to train them to effectively serve as tribunal secretaries. This training is being offered in collaboration with AIADR, Malaysia to be conducted at IAMC, Hyderabad in November 2025.

Advanced International Arbitration Training

Ms. Anandita Rajesh is working in close coordination with international experts in Arbitration, including FCiArb members, to design and curate an advanced international arbitration course that would equip our panel arbitrators to deal with complex international and cross border commercial disputes. The course is planned for launch towards the end of 2025.

Civil/ Commercial Mediation Training with ADR ODR

IAMC Hyderabad, in collaboration with ADR ODR International India, will be organizing a comprehensive Civil/Commercial Mediation Training in September 2025. This internationally recognized programme is accredited by SIMI, IMI and CMC (UK). The training is designed to equip participants with mediation skills and competencies aligned with global standards in both domestic and cross-border commercial disputes.

Community Mediation Training Programme in Collaboration with Panchayat Resolution Centre

04

IAMC Hyderabad is collaborating with the Panchayat Resolution Centre, an NGO, to promote community mediation and improve access to dispute resolution in villages through a revival of the traditional dispute resolution method through panchas trained in modern mediation techniques. As a part of this collaboration, IAMC Hyderabad will conduct the Community Mediation Training Programme and provide inputs for promoting the concept of community mediation in rural areas.

I. Letter of Support



IV. Woxsen University, Hyderabad

Lastly, IAMC suggested the implementation of its Med-Arb model for resolving disputes efficiently through a structured process combining mediation and arbitration.
